

Title 1. Section 1. AN ORDINANCE OF FAIRFIELD TOWN, UTAH, PROVIDING FOR THE COMPENSATION OF ELECTED AND STATUTORY OFFICERS ORDINANCE NO. 082217

Dated 22 November 2022.

An Ordinance of Fairfield Town, Utah, providing for the Compensation of Elected and Statutory Officers, Created August 22, 2017,
Renamed "Compensation of Elected and Statutory Officers" and Revised 12 September 2019 and
Revised 22 November 2022.

**Chapter 1
General Provisions.**

1.1.1.1 Purpose.

WHEREAS, the number of duties assigned to each elective officer has increased significantly, and each elected officer is required to devote more time to the effective administration of Fairfield Town; and

WHEREAS, public service obligates elected officers to spend their own money in the service of the town, and

WHEREAS, the Fairfield Town Council finds that elected, and statutory officers should be fairly compensated for their time and expenses, and

WHEREAS, Fairfield Town has sufficient funds in their budget, and

WHEREAS, Compensation does not exceed 25% of the overall budget,

1. All previous salary or compensation ordinances regarding elected and statutory officers of Fairfield Town are repealed as of **22 November 2022.**
2. A new Chapter 2 is adopted to read as follows:

**Chapter 2
Compensation of Elected and Statutory Officers.**

1.1.2.1 Compensation for Elected Officials.

1. Compensation for all elected officials of Fairfield Town shall be fixed according to the following schedule:

Mayor / Town Administrator	\$700.00 per month plus \$50.00 per meeting
Town Council Members	\$50.00 per meeting

2. The Mayor and the Town Council may accept compensation or remuneration from other boards, councils, committees, or commissions on which they serve as part of their official duties as a Fairfield Town Council member. They may also be hired by the Fairfield Town.

3. The salaries and benefits set by this ordinance shall be effective **22 November 2022.**

1.1.2.2. Compensation for Statutory Officers.

1. Compensation for all appointed officers of the Town shall be fixed according to the following schedule:

Recorder/Clerk	Compensation set by Town Administrator.
Treasurer	\$350.00 per month.
Planning Commissioners Members	\$50.00 per meeting
Director of Roads Department	\$350.00 per month.
Director of Water Department	\$350.00 per month.
Director of Building	\$250.00 per month.
Deputy Recorder	Compensation set by Town Administrator.
Finance Director	Compensation set by Town Administrator.
Water Operator	\$425.00 per month

Any work performed outside of the job description and approved by the Town Administrator will be set at \$50 per hour.

1.1.2.3. Compensation Payment and Adjustments.

1. Per Diem. Each member of the governing body shall receive mileage and per diem for all trips approved by the government body according to the schedules adopted by the Utah Division of Finance, excluding the Mayor.

2. Compensation payment will be paid monthly for the elected officials and statutory officers.

3. Compensation payment for member attendance for the Town Council meetings and the Planning Commission meetings will be paid yearly at the end of the calendar year.

**Chapter 3
Effective Date.**

1.1.3.1. This ordinance shall take effect upon its adoption and publication or posting by the Town Council of Fairfield Town, Utah, on this **22nd day of November 2022.**
